In terms of Section 14(1) of the NCTE Act, 1993 Karuna Shikshak Prashikshan Mahila Mahavidyalaya had submitted an application (Code No. APN-1681) to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed. course of One year duration with an annual intake of 100 students.

2. On the basis of the scrutiny of the documentation submitted by the institution, input received from the Visiting Team Report, the NRC in its 105<sup>th</sup> meeting held on 28<sup>th</sup> – 30<sup>th</sup> July, 2006 noted the following compliance required to be made by the institution before the commencement of the academic session 2006-2007.

**A. Appoint duly selected staff with the requisite qualification as per NCTE norms and standards and inform the Northern Regional Committee**

In view of the above the Committee decided to issue a conditional recognition to the institution and also advised to make the compliance of the above preferably within 21 days from the date of issue of this letter.

3. The institution shall undertake appointment of staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. However, in case duly qualified staff are not available, for relaxation in terms of the requirement relating to passing of NET / SLET / Ph.D etc., the institution may refer to the NCTE Regulations dated 21.07.2006 (copy enclosed) and comply accordingly.
